

## **AGREEMENT TO MUSHROAMING TOURS TERMS & CONDITIONS:**

By submitting your payment for a *Mushroaming Tour* you are agreeing to all terms and conditions listed below.

### **OUR RESPONSIBILITIES:**

*Mushroaming Tours* exercises reasonable attention in booking accommodation and organizing local transport and sightseeing arrangements, however, we do not assume any liability whatsoever, for any injury, damage, loss, accident or delay to person or property because of any acts of war or terrorism, any act of default of any hotel, carrier, restaurant, company or person rendering any of the services included in the tour. The tickets, coupons, tariffs, rules or contracts currently in use by any carrier, hotel, restaurant or other contractor rendering services shall constitute the sole contract between such contractor and the tour member. *Mushroaming Tours* accepts no responsibility for any damage or delay due to sickness, pilferage, labor disputes, machinery breakdown, quarantine, government restraints, weather or any other cause beyond our personal control. **It is therefore imperative that you purchase comprehensive travel insurance** and notify *Mushroaming Tours* of your policy number before you travel. *Mushroaming Tours* reserves the right to cancel or change itineraries, or substitute services without notice and to decline to accept or retain any participant at any time.

### **TOUR PRICE – Local adjustments:**

Tour prices unless noted, are based on land rates and rates of exchange in effect at the time of arrangements. All rates can be subject to change without prior notice. Should the rates go up substantially prior to departure, an adjustment will be made. However, in our more than 10 years of operation we never adjusted our tour prices so far. As all services are contracted and prepaid on a group basis, no refunds can be granted for any pre-booked accommodations, services or events which are not used. If you deviate from the tour, no consideration can be given to a refund for unused services.

### **CANCELLATION TERMS:**

Any cancellation must be made in writing (email). Cancellation charges are as follows: cancellation 150 – 90 days before commencement of tour: 40% of cost; cancellation 89 – 45 days before commencement of tour: 65% of cost; cancellation less than 45 days before commencement of course: 100% of cost. In exceptional circumstances, the charge may be negotiated, however accommodation and local transport costs will still need to be covered if no one can take your place.

If a tour is under subscribed we may cancel; in this case a full refund (including deposit) will be made.

### **PASSPORTS & VISA:**

It is your responsibility to ensure that your passport is up to date and that you supply us with your name exactly as shown in the passport. *Mushroaming Tours* generally provides information re visa requirements but it is up to you to meet the necessary visa requirements for the country you are traveling to.

### **HEALTH REQUIREMENTS:**

Please advise us of any existing health conditions and make sure you carry sufficient medication for any medical conditions. *Mushroaming Tours* reserves the right to decline any trip participant whose condition, in our opinion, may affect the health, safety or enjoyment of other participants. *Mushroaming Tours* will do the utmost to assist in the case of an emergency but is not responsible for the costs of any medical treatment or the quality of medical care, or lack thereof, you may receive while on the trip. It also your responsibilities to make sure your travel vaccinations are up to date. *Mushroaming Tours* will not have liability regarding the provision of medical care of any illnesses or accidents that occur before, after or during the course of the tour.
